# III PROPOSED CONSERVATION EASEMENT APPLICATIONS

- A) Wieczorek Property Ken Schroeder had a few questions about the work session and how many of the Town Board members were against the easement. Ken did speak with Mr. Wieczorek and he still only wants to do a term easement and not a perpetual easement. Bill Jackson made a motion to have Bryant Zilke go before the Town Board and again present the easement application for consideration. Kim O'Rourke seconded the motion, all yes. Bryant will contact the Supervisor to see when this can go on an agenda.
- B) Jones Property Barbara Jones was in and spoke to Kerry about her survey and she was going to look for the original. A new copy of the survey was brought in and Barbara also picked up a copy of the agreement to review.
- C) Rupp Property (641 Ostander-35 acres) Kerry will check with the Assessor on preliminary tax numbers for this property. Once we receive the numbers Kerry will send to the ECB members to review and then the property will be submitted to the Town Board for review. Kim approved the motion and Howard seconded the motion, all yes. The work session is on December 13 that this may be reviewed at.

- D) Maciejewski Property The ECB needs to check with the Town Board to see if the 3 acres that is being submitted is enough acreage to move forward with the easement. We are waiting on this property until the Jones property is finalized.
- E) Informational Handouts The Assessor Kandy Wittmeyer has the list of potential 20 acre parcels that the ECB will be sending information to regarding the easement program. Bill Jackson commented that the presentation should have the mission statement of the ECB at the beginning of the presentation. Kerry is going to check on having copies of the booklet and pamphlet done by Elma Press.

#### A) Historical Preservation

Ray sent an email to Dennis Powers on the preservation program and is waiting for his comments, Kerry is going to check on the status.

### B) Solar Farm Committee
