## 12/15/10 Town Board Minutes

A regular meeting of the Elma Town Board was held on Wednesday, December 15, 2010, at 7:00 PM, Elma Town Hall, 1600 Bowen Road, Elma, New York, with the following members present:

Approximately 9 people attended the meeting.

The meeting was opened with the reciting of the Pledge of Allegiance.

Making the legal notice on the public hearing for Drainage District #187 for Transit and Bullis Roads, Transit Commons part of the minutes Supervisor Nolan opened the Public Hearing at 7:01PM. Speaking for the Drainage District #187 was Mr. Schutt from Wm Schutt Associates. No one spoke against. Supervisor Nolan closed the public hearing at 7:02PM.

Councilman Powers made the motion and Councilman Puleo seconded the motion to approve Drainage District #187 for Transit Commons at Transit and Bullis Roads. Ayes-5. Noes-0. Carried.

Councilman Powers made the motion and Councilman Fallon seconded the motion to approve the minutes from the December 8, 2010 meeting. Ayes-5. Noes-0. Carried.

Councilman Fallon made the motion and Councilman Petrocy seconded the motion to approve the resolution for a budget transfer to increase appropriations for Control of Dogs as follows: WHEREAS, the Town wishes to increase the appropriations line for the control of dogs, and WHEREAS, the Town Board wishes to provide funding for the dog licenses and cell phone, and WHEREAS, the Town's 2010 adopted budget does not currently include such funding NOW, THEREFORE, be it RESOLVED, that the Town Board hereby authorizes the transfer of budgetary appropriations in the Town's 2010 adopted budget as follows: Increase Appropriations: A3510.413 Control of Dogs-Cell Phone \$500.00; A3510.414 Control of Dogs-Dog Licenses \$2,000.00. Decrease Appropriations: A1990.400 Special Items-Contingent Account \$2,500.00. Ayes-5. Noes-0. Carried.

Councilman Petrocy made the motion and Councilman Fallon seconded the motion to

approve the resolution for a budget amendment for insurance loss at the Highway Garage as follows: WHEREAS, the Town has experienced an insurance loss at the Highway garage, and WHEREAS, the Town's 2010 adopted budget does not currently include the appropriations for the insurance loss of the materials and supplies NOW, THEREFORE, be it RESOLVED, that the Town Board hereby authorizes the amending of the 2010 adopted budget to include the appropriations for the materials and supplies as follows: Increase Appropriations: DA 5132.402 Material & Supplies-Insurance Loss \$15,000. Increase Estimated Revenues: DA 2680 Insurance Recoveries (\$15,000.00). Ayes-5. Noes-0. Carried.
