IIb. LETTER TO WNY LAND CONSERVANCY (WNYLC)

As a result of the amendments to the Minutes of 7/25/06, there was further discussion regarding Springbrook Shores and the initial involvement by the WNYLC in that conservation easement process. Based upon the Board's concerns for "loop holes" in the current Conservation Easement Agreement with Springbrook Shores as identified by an experienced attorney from the WNYLC; and in an attempt to preserve open space for future generations, it was determined that the ECB, in an effort to protect the Town of Elma, seek advice before entering into any other easement agreements. Therefore it was decided that Bryant Zilke and William Jackson would write a letter to the WNYLC. Motion to Approve by Bryant Zilke and Second by William Massaro. Ayes: 7. Nays: 0. Motion carried.

III ECB BASELINE DOCUMENTATION POLICY

According to William Jackson who designed this document: "It is intended to define whatever the easement is designed to protect. There are no prohibitions in here." Item 6. was expanded to clarify the process and Item 8. was changed from three to four copies of the BDR, the fourth copy to be attached to the final easement agreement and filed in the Erie County Clerk's Office as a permanent record.
