## **Review of Application Status**

Bryant will need to meet with the Supervisor and Town Attorney to discuss what the process is for an easement to be finalized. Bill spoke about his visit to the Fox Run property which is roughly 16 acres. Bill displayed the survey showing the shaded section of green to be the part that is included in the easement program. Bill wrote up a description of what he viewed while he walked the property. The neighbor behind the property has a perpetual easement with Genesee Valley. Bill will send copies of his write up to all the ECB members in an email. The ECB will review this property at the meeting next month. The question was brought up about if we are going to require a separate survey for the excluded portion vs. the included portion for the easement.

Larry and Mike will handle the new file for Scott Meyers and Donna Jusiak. Kerry will email a copy of the application to both members so that they can contact the homeowners. Bill Jackson had to leave at 8:25 pm.
