Reconstructed 150ft of W Jerge digging existing road completely out, installing drainage & base material & repaved. Did set up & clean up for fireworks. Removed flags along Bowen for the Kiwanis. Mowed Parks, Town Hall & Library. Patched & swept Town Hall parking lot for sealing. Assisted Water Dept with equipment & manpower for water main break on Bullis Rd. Weather permitting the recycling project on Woodard Road is scheduled to begin July 22nd. Also the new Freightliner truck is in service. Town Attorney Phyllis Todoro advised the Town Board to secure the tennis/basketball courts at the Creek Road Park until repaired.
